INVITATION TO PARTICIPATE AS A VOLUNTEER TRAINEE INSPECTOR IN THE MOTOR BODY REPAIR INDUSTRY NATIONAL GRADING STANDARDS FOR OUT OF WARRANTY MOTOR VEHICLES - CERTIFICATION PROJECT

Dear SAIA Member,

The South African Insurance Association (SAIA) together with the Motor Body Repair (MBR) Associations hereby invite eligible persons in the motor body repair or short term insurance industries, to apply to participate in the MBR industry certification project, as trainee inspectors.

The certification project is an initiative by the short-term insurance industry together with the MBR Associations, under the Motor Transformation and Sustainability Forum (MTSF) banner, to ensure that motor body repairers adhere to a set of minimum standards. The lack of a single, uniform standard for non-structural and structural repair of motor vehicles, out of warranty, was identified as a barrier, especially for small black-owned MBRs. It is hoped that by introducing and adhering to one standard, equal opportunity is created to compete for insurance work, whilst providing assurance of the quality of repair work performed.

We are looking for 40 trainee inspectors across South Africa. These individuals will be paired with qualified independent inspectors to assess motor body repair shops, against the mentioned standards, with the intention to certify them.
